- 1. Call to Order by Lan Chan, Chair of AGM. Quorum met.
- 2. Approval of Agenda moved by Michael Lee and seconded by Raymond Ng. Motion carried.
- 3. Approval of minutes for last AGM of July 17, 2014. Moved by Henry Fung and seconded by Raymond Ng. Motion carried.
- 4. Report to members by Lan Chan. See page 3 of 2015 AGM booklet. This was received as information.
- 5. Financial Report December 31, 2014– Treasurer Sein Mah presented the unaudited financial statement of 2014 (pages 4 to 7 of AGM booklet). Moved by Mei Hung and seconded by Frank Gee to accept the financial statement as presented. Motion carried.
- 6. Appointment of Accountant for 2015– Moved by Sein Mah and seconded by Anh Phuong to reappoint Donald Mah & Associates as CBA's accountant for 2015. Motion carried.
- 7. Election Committee report Peter Vuong, Chair of the Election Committee –reported that the Election Committee consisted of 5 community members, namely Ed Lam, Lieu Kah Hing, Nam Chau, Stephen Tsang and himself. Applications for board position candidates was closed on May 22, 2015 with 31 applications for the 23 CBA board positions. Election was held on June 7 at the CBA Community Hall from 10:00am to 4:00 pm. 29 members voted. Dr. Michael Lee was elected as the President of CBA by acclamation at the CBA Board Meeting on June 13, 2015 under the jurisdiction of the Election Committee.

- 8. Message from 2013-2015 Chair Mei Hung expressed her sincerely thanks to all the community organizations, board members and volunteers for the support provided over the years. She outlined activities over the past year and also the key issues that need to be monitored. Her report is outlined in the AGM report, from page 10 to page 12 and is received for information.
- 9. Message from 2015-017 Chair Dr. Michael Lee thanked the community members for their ongoing support. He indicated Chinatown is facing significant changes resulting from new developments and the LRT construction. He also mentioned that the interest of the Chinese Community must be protected. This can be achieved through a strong voice with a united front. His report is outlined on page 13 and 14 of the AGM report and is received for information.

MESSAGE FROM THE CHAIR



Dear Friends,

If you are a follower of what has been happening in Edmonton Chinatown this past year, you will no doubt remember a few significant events that have placed the Chinese Community in the city lime light. On the cultural and entertainment side, the CBA presented the Mid-Autumn Festival in Churchill Square at the heart of downtown Edmonton which was widely acclaimed as a fun and welcoming event filled with traditional sight and sound and attracted thousands of Edmontonians and visitors. A similar event, albeit on a smaller scale, held on Canada Day in the Traditional Chinatown district also drew very favorable comments from thousands of peoples.

The Chinatown Conference hosted by the CBA in June 2016 attracted participants from nine cities across North America. It was held at the University of Alberta and served as a platform to share concerns and successes of various Chinatown communities. The two day conference was likely the first such gathering anywhere and its success is certainly the result of the hard work and dedication of many outstanding individuals under the leadership of Lan Chan-Marpole, who also lead the Mid- Autumn Festival earlier on.

The City of Edmonton is very keen on formulating a plan for the future development of Edmonton Chinatown. We have been working closely with the City task force to make sure that our concerns and ideas are properly conveyed to the City Council. In the next few years, this development plan will be one of the main focuses of our attention.

One piece of very exciting news announced by the Edmonton Public School Board informed us that there will be a new school in west Edmonton bearing the name Kim Hung, to be open in September 2017. As you all know, Kim was a towering figure in the Edmonton Chinese Community and the legacy of his work is seen everywhere around Chinatown. It will be a big celebration next year at the opening of the school.

If CBA has achieved any degree of success in the past year, it would be mainly due to the loyal support of many Chinese Community Organizations who have generously contributed manpower, material and financial support, often on multiple occasions. The CBA is deeply grateful to them and hope our cooperation will last for many years to come.


